PART 1 GENERAL

1.1 SECTION INCLUDES

- A. Diaper changing stations.

1.2 SUBMITTALS

- A. Product Data: Manufacturer's data sheets on each product to be used, including:
 - 1. Preparation instructions and recommendations.
 - 2. Storage and handling requirements and recommendations.
 - 3. Installation methods.

1.3 DELIVERY, STORAGE, AND HANDLING

- A. Store products in manufacturer's unopened packaging until ready for installation.

1.4 PROJECT CONDITIONS

- A. Maintain environmental conditions (temperature, humidity, and ventilation) within limits recommended by manufacturer for optimum results. Do not install products under environmental conditions outside manufacturer's recommended limits.

1.5 WARRANTY

- A. Warranty: Provide manufacture's standard limited 5-year warranty. All warranties are effective from the date of initial shipment from manufacturer.

PART 2 PRODUCTS

2.1 MANUFACTURERS

- A. Acceptable Manufacturer: The Sova Company
- B. Substitutions: Not permitted.

2.2 DIAPER CHANGING STATIONS

- A. Diaper changing stations shall meet ASTM safety standards, include ANSI warning labels, and shall be ADA compliant when installed.
- B. Aura Frameless Surface Mount with Full Stainless Steel Warp Changing Station:
 - 1. Product: 25HS0206 – Aura Frameless Surface Mount with Full Stainless Steel Warp Changing Station as manufactured by The Sova Company.
 - a. Surface mounted, required mounting surface 16.9 inches (430 mm) high by 34.7 inches (881 mm) wide.
 - b. Changing surface extends 17 inches (432 mm) from wall in open position.
 - c. Replaceable high-hygiene polystyrene tray.
 - d. Constructed of heavy-duty type 304 brushed stainless steel.
 - e. Pneumatic gas spring provides easy and safe open/close operation.
 - f. One-hand operation safety strap.
 - g. Cushioned safety corners.

PART 3 EXECUTION

3.1 EXAMINATION

- B. If substrate preparation is the responsibility of another installer, notify Architect of unsatisfactory preparation before proceeding.

- B. Aura Frameless Surface Mount with Full Stainless Steel Warp Changing Station:
 - 1. Product: 25HS0209 – Aura Frameless Surface Mount with Full Stainless Steel Warp Changing Station as manufactured by The Sova Company.
 - a. Surface mounted, required mounting surface 16.9 inches (430 mm) high by 34.7 inches (881 mm) wide.
 - b. Changing surface extends 17 inches (432 mm) from wall in open position.
 - c. Replaceable high-hygiene polystyrene tray.
 - d. Constructed of heavy-duty type 304 brushed stainless steel.
 - e. Pneumatic gas spring provides easy and safe open/close operation.
 - f. One-hand operation safety strap.
 - g. Cushioned safety corners.
